

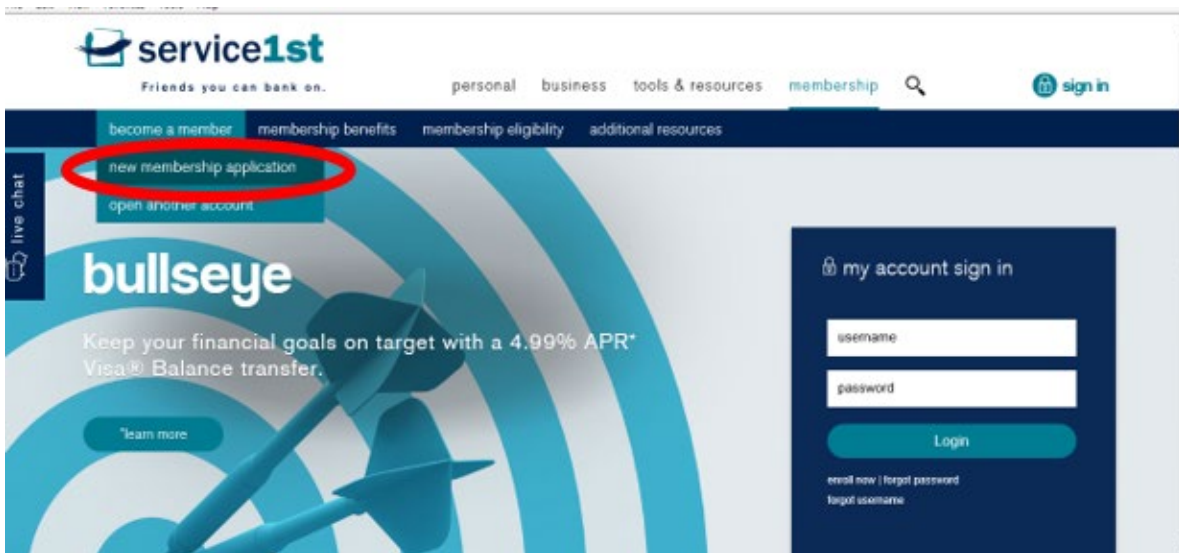

Online Membership Application Process

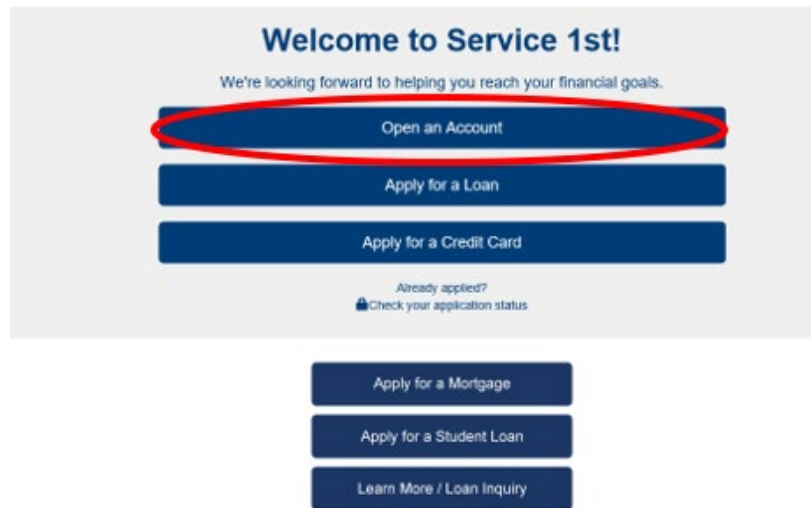
Step 1: Visit www.service1.org to start your new membership application today. The following steps will help you through the process. If you have questions at any time, call our Contact Center at 800.562.6049.
